Tuition can be paid by one of the three plans listed above. The first payment on all plans is due on June 1, 2012. Tuition is refundable as follows: 75% during first week of classes, 50% during second week of classes, 25% during third week of classes, and not refundable after third week of classes. After this point, you are responsible for 100% of your remaining tuition for the year regardless of which plan you choose or when you withdraw.

VPK Students:

VPK-only students do not pay registration fees or tuition for either morning or afternoon VPK sessions. If VPK students remain for the whole day, utilize before or aftercare, or lunch bunch, registration fees for the remaining part of the day apply and will be billed.

Discounts Offered:

Multi-Child	Second Child discount is 5% and all remaining are at 10%. If multi-child discount falls in Preschool, there will be a 5% discount for that child.
Pastoral	50% off tuition schedule above • You must be ordained by the governing body of your church and be serving as a <u>full-time minister of the Gospel.</u>
FPC	\$500 discount off of your tuition for each child per year • Applies to members of First Presbyterian Church in good standing only • Applies to tuition only.
Preschool	All current Coral Springs Christian Academy Preschool children will receive a \$500 discount off of annual tuition for Kindergarten. • Applies to tuition only.

Tuition Payment Schedule • 2012-2013 School Year

Annual Plan:

Tuition is due in full on June 1, 2012.

Semester Plan:

Tuition is due in two equal payments to be made on June 1, 2012 and October 1, 2012.

Monthly Plan:

Tuition is due in eleven (11) payments from June 1 – October 1, 2012 and December 1 – May 1, 2013. For 2012-2013 you must be enrolled in the PayEasy tuition autopay program. Your enrollment will not be complete until you enroll in this program.

Seniors:

All tuition and fees must be paid in full by May 1st in order to graduate with your class. PayEasy accounts for Seniors will have 11 payments from June 2012 to April 2013.

McKay and Florida Step Up For Students Awards:

McKay and Florida Step Up For Students programs are paid by the State of Florida quarterly. It is your responsibility to come in and sign the checks when they are available. Checks that are not promptly signed will be subject to a \$30.00 late fee. Award recipients must pay their portion of tuition based on one of the above payment plans.

Fees Schedule • 2012-2013 School Year

Late Fees:

Late fees (\$30.00 per month) will be assessed on any account that has outstanding balance due after the 10th of the month. ***If the 10th falls on a weekend, you must pay before the weekend to avoid a late fee.*** PayEasy payment plans are late the day after the date of your automatic payment, in the event your payment does not clear your bank.

NSF Fees:

Non-Sufficient Funds fees (\$30.00 per incident) will be assessed on any account that has a payment returned by your bank uncollected. It is your responsibility to make sure funds are available in your account at the time payment is made.

Preschool Fees:

The Lunch Bunch program for morning students requires a \$30 registration fee. There is a \$15 per day charge from 11:30am-2:30pm.

Other Information

- All tuition and fees must be current to re-enroll, receive report cards and records, and to maintain RenWeb privileges.
- **Parents of past due accounts over 60 days will be asked to withdraw their children until the account is brought current or arrangements are made with the Finance Office.**
